Health Insurance MOU

With the transition of our insurance benefit programs to Cigna Health and Guardian this fall creating overall cost savings it became necessary to modify contribution levels provided by the school corporation. Since the changes are to be implemented prior to the start of this fall's collective bargaining negotiating period it is necessary to enter into a Memorandum of Understanding. A copy of the MOU has been provided for board consideration for approval.

2020-09-084 SUPERINTENDENT REPORT OUT

Pathfinding

CCSC has been approved as an entity eligible to apply for emergency funds from FEMA, as related to the added costs due to the COVID-19 Pandemic. While our plan may change, currently the thought is to apply for reimbursement of PPE costs. The FEMA grant is at a 75% reimbursement rate, if we are approved for reimbursement.

Our CARES Act Budget has been approved by the Indiana Department of Education. The budget may be amended. Our actual use of these funds will depend on the acceptance of our FEMA request.
