2020-09-090 2020 - 2021 CCSC School Reentry Plan

Dr. Smith presented the 2020-2021 CCSC School Reentry plan. The plan has been created through a collaborative process that has included:

- Reentry Committee, consisting of building leadership, athletic directors, parent representation, school nurses, and teacher representation.
- Collaboration with the Fountain/Warren County Health Department.
- Guidance from the IDOE, Indiana State Department of Health, the CDC, and school leaders in the region and state.
- Parent Surveys.
- Discussions with school community stakeholders.
- Input from board members.

With the above in mind, it is recommended that the 2020 - 2021 CCSC School Reentry Plan be approved as presented (with the requested changes - if required).
